The Highland Township Board of Supervisors (BOS) met on this date at 7:00 p.m., as publicly advertised, at the Highland Township Municipal Building at 3641 Fairfield Rd. Gettysburg, PA 17325

PUBLIC COMMENT

Resident voiced concerns over traffic and accidents occurring on Rt.116. She wanted to know if something could be done about speed. She also questioned if anything in ordinance about beautification/upkeep of properties. She has concerns neighboring property is not being upkept properly. Resident also wanted to know if there are any incentives for owners to improve properties.

Another resident said there has been 1 accident/year near Cold Springs Road for the last 3 years. She feels that concerns should escalate to state level. She presented a crash analysis report for 2021-2023. She stated there are ways to get people to slow down. It was explained that Rt. 116 is a major road for first responders and the ways described to slow down speeders would affect first responders.

Resident had concerns over grass blown on Knoxlyn-Orrtanna Road. Officer DeWitt stated he saw the grass and went to the home no one answered door. Resident also have concerns with "donuts" at intersection of Knoxlyn and Knoxlyn-Orrtanna Road. He would like an increase in police hours.

Bruce Strasbaugh presented Cashtown Fire Dept. financial statement for 2023 as well as 990 Form.
